ENROLMENT AND RE-ENROLMENT

CANCELLATION AND REFUND POLICY

If you cancel your enrolment within 7 days of receiving your initial study material, you may return your material to us, and, if it is received in good condition, we will refund your payment less a cancellation fee to cover postage and administration costs incurred (a nominal charge may be made for any material returned damaged to us).

If you wish to terminate your study within 3 months of enrolment, a partial refund of the course fees paid may be possible, see below. Refunds are not normally provided beyond this 3-month period. Apart from the 7-day initial period, we do not accept the return of study units sent to you, whether or not you have used them.

Refunds: All requests for refunds must be made within 3 months of registration. Refunds will only be given for any unused tutor marking portion of your fee, not for any materials sent to you. A cancellation fee will be charged to cover administration costs incurred

1. Drugs taken occasionally for symptomatic relief
2. Drugs taken regularly for relatively mild disorders
3. Drugs which cannot be stopped suddenly if taken long-term
4. Drugs used for relatively severe mental/emotional symptoms
5. Drugs used in cases of life-threatening disease

There is a discussion of the energetic qualities of prescribed drugs based on the perspective of Chinese medicine. A comprehensive index allows drugs to be found quickly and easily. This book is an invaluable guide for all holistic practitioners and their patients.
